RULES IN CASE OF EMERGENCY

Report the emergency immediately to plant personnel.

Remain calm, do not run.

Follow the instructions of designated emergency personnel.

Remain inside your vehicle or in the vicinity of your vehicle.

In the event of an evacuation order:

Immediately vacate the premises, with your vehicle (if possible).

Remain calm, do not run and do not stop at the exits.

Use the evacuation routes established for this purpose, remain at the meeting point until further notice.

If you are trapped by smoke, duck and crawl out.

SPECIAL WORK

(Welding, hot work, electrical work and work at heights)

Special work requires the authorization of the person in charge of the installation.

OTHER RULES

Keep the workplace in optimum conditions of order and cleanliness.

Collect any waste that may be generated during the stay and deposit it immediately in the corresponding container.

No maintenance must be carried out during the stay in the facilities. In cases of urgent necessity, and **always with the prior authorization** of the person in charge of the facilities, you may carry out occasional maintenance work.

IN THE EVENT OF AN ACCIDENT

Remain calm. Observe the situation before acting.

Call for medical assistance.

Examine the injured person thoroughly without touching him unnecessarily.

Act promptly but without haste.

Do not move an injured person without first knowing what is wrong with him.

Never give water to someone who is unconscious.

Do not allow the casualty to cool down.

Accident person in flames:

- Cover with a blanket or jacket.
- Cool with water. Do not remove clothing.
- Emergency transport.
